Sec. 34-47. Permit required for Street and Driveway Construction.

It shall be unlawful for any person to construct a driveway, road, street, or thoroughfare upon or adjacent to any public road within the county so as to intersect with the road unless such person shall first obtain a permit to construct such driveway, road, street or thoroughfare for the purpose of gaining access to the public roads of the county. (Ord. of 8-28-2007(2), 1001)

Sec. 34-48. Driveway Permit Application.

Any person-wishing to construct a driveway, road, street or thoroughfare upon or intersecting with the public roads of the county shall make an application to the office of the Board of Commissioners in the county courthouse and pay a fee with the application as provided in the county fee schedule. The Board of Commissioners will provide for the application to be considered within three business days and will instruct the applicant of the requirements necessary to provide access to the county road. Each access shall be constructed in a manner which will not damage the public or county roads. (Ord. of 8-28-2007(2), 1002)

Sec. 34-49. Inspection.

Any driveway, road, street, or thoroughfare as described in Sections 34-47 and 34-48 shall be subject to inspection prior to issuance of a permit to connect to the county road. The appropriate official as designated by the Board of Commissioners may consider any plans or other evidence deemed sufficient to inform the county of the intended construction of any such driveway. The permit issued by the county to construct any driveway, road, street, or thoroughfare may include specifications for the grade, gravel, or other construction specifications so as to provide for the orderly management of the public roads within the county and their connection to private ways for access. (Ord. of 8-28-2007(2), 1003)

DIVISION 3. RIGHT-OF-WAY CONSTRUCTION PERMIT

Sec. 34-72. Permit for construction within county rights-of-way.

It shall be unlawful for any person to commence construction within the right-of-way of any public road within the county unless the person shall first obtain a permit for the construction of any utility lines or other necessary cuts within the right-of-way. Ord. of 4-28-1995(2), 1) CD34:4

ROADS, STREETS, BRIDGES, OTHER PUBLIC PLACES

Sec. 34-75. Permit may be issued subject to construction specifications.

The permit issued by the county may include specification for grade, compaction, or other construction specifications so as to provide for the orderly maintenance of the public roads within the county. (Ord. of 4-28-1995(2), 3)

Sec. 34-76. Standard of Construction generally.

Each cut shall be performed in a manner which will mitigate damage to the public or county road and repair to the road shall be promptly made to the specifications determined appropriate by the official designated by the county Board of Commissioners to oversee the construction and repair work. (Ord. of 4-28-1995(2), 2)

Sec. 34-77. Inspections.

Any road, street, or thoroughfare shall be subject to inspection prior to issuance of a permit to construct within the county. (Ord. of 4-28-1995(2), 3)
